



**SALES AND CANCELLATION CONDITIONS
FOR FIT STAYS
via the booking on line www.courchevel.com**

DEPOSIT

Self-Catering accommodation: a minimum of 25% deposit is required for the booking to be confirmed and has to be paid directly to the accommodation supplier.

Hotel: a minimum of 43% deposit is required for the booking to be confirmed and has to be paid directly to the hotel supplier.

Services (Activities, restaurants, Services): 100% deposit is required for the booking to be confirmed and has to be paid directly to the Services supplier.

BALANCE

Balance has to be paid 1 month prior arrival to the supplier directly.
Any delay will be accepted otherwise your booking will be cancelled and deposit will not be refunded.

CANCELLATION POLICY

General conditions

In case of cancellation by the client, the sales and cancellation conditions of the accommodation or services provider will apply. All cancellations must be sent to the services suppliers in writing (fax, mail or email).

Cancellation Insurance

No cancellation insurance is included in the prices offered on the web site. If you contract cancellation insurance to one of our services suppliers, then their cancellation clauses and conditions will apply.

Cancellation clauses for all the outdoor activities

Some outdoor activities could be cancelled cause of bad weather, or in case of force majeure, or when number of participants is not enough to assure the activity: in that case, the activity will be postponed or refunded by the services supplier.

SPECIFIC CONDITIONS FOR HOTELS

Rate includes services. They have been calculated according to the number of people mentioned during the booking.

Check-in and check-out

Check-in and check-out policy is according to each hotel.

SPECIFIC CONDITIONS FOR SELF-CATERING ACCOMMODATION SUPPLIERS

Additional person

Apartments have a precise bedding number as defined in the description. The owner and/or the agency has the right to turn down the rental of the accommodation if an unexpected person is present.

Guarantee

A guarantee fixed by the owner or the real estate agency will be claimed at the pick-up of the keys. The guaranteed will be withdrawn in case of damage or/and of dirty state if the end of stay cleaning is not included in the booking.

Check-in and check-out

Policy of the check-in and out (location and schedule) will be given by the accommodation supplier.

FINANCIAL CONDITIONS AND PAYMENT

Unless specified clauses stated, the price of the services provided are listed in euros, excluding the tourist tax.

Payment has to be made directly to the services supplier upon booking, by entering details card number on our secured on line booking web site or directly to the hosting supplier.

TOURIST TAX FOR ACCOMMODATION

A city tax is applicable in the resort of Courchevel and depends upon the type of accommodation. It has to be paid to the host during your stay.
